

#### **EcoValor Project's Scope**

- Contribute to the international commitments (i.e. Aichi Targets)
- Develop and implement a diversified longterm valuation strategy to support conservation efforts, management and sustainable use of PA
- Integrate the values that ecosystem services provide into decision-making processes
- Strengthen the conservation economics of CONANP's 2040 strategy
- Contribute to reduce the current financial gap of Mexican Protected Areas' operation

- Systematize information to raise awareness about the value of key ES in PA
- > Convey the importance and position PA on the national agenda
- Design economic instruments and institutional arrangements to reward biodiversity and ES conservation
- Foster human well-being inside and beyond PA





# Priority ES in the MBBR








# Video

- Systematize methodologies to replicate this exercise throughout Mexico's PA system




# Communicate the value

Communicate the value to decision makers, to the people living in the MBBR, and to people depending on ES (urban population)

- Convey the link between ES and human and economic well-being
- Incorporate the importance of ES into the national agenda
- Recognize that PA are source of important ES








- » Develop technical capacities for managers and its partners to value ES
- » Incorporate the approach of valuation of ecosystem services into the actualized Management Plan of the MBBR
- Strengthen local governance through the inclusion of a VSE focus into community-based development planning



#### Mainstream ecosystem services





- » Recognize sustainable management practices to foster alternative economic activities for people living inside and on the outskirts of the reserve
- » Build strategic alliances to integrate an Ecosystem Services Valuation approach into current existing dialogues and alignment of public policy
